Transmission System Operations

Senior Director Operations – T/S

- Manages compliance to construction specifications, operating standards and procedures
- Ensures compliance to all NERC reliability standards in the various regions throughout North America
- Coordinates with NextEra Energy Transmission Development team to support bid responses, testimony, and overall strategy to potential new and existing projects as part of the overall growth strategy for NEET
- Promotes quality concepts and aid in the development of the field engineering team and system operations and continuously evaluate and improve the execution of critical operation and maintenance processes

Director Operations – T/S

- Ensures compliance with all safety, environmental and regulatory requirements
- Evaluates and improves the execution of critical operation and maintenance processes
- Provides oversight and leadership in the development and implementation of standardized work practices and cost effective execution program
- Directs planning, budgeting and execution of distribution, transmission, and substation maintenance and reliability work
- Coordinates and interfaces with regulatory agencies and interconnected entity operations organizations
- Oversees implementation of transmission benchmarking efforts
- Drives and fosters strategy for condition assessments

System Operator TBC

- Takes and logs periodic readings; identifies and responds to disturbances, deviations, alarms and events from the operator work stations
- Makes necessary call-outs for service on a timely basis
- Operates and maintains all systems associated with the facility
- Executes switching operations to safely isolate the facility for maintenance work, ensuring compliance with the facility's safety manual and all associated codes and regulations
- Administers operating logs, disturbance, outage, equipment failure reports, and additional reports or records as required
- Communicates effectively with the control room staff of the California ISO, (CAISO), Balancing Authority (BA), Reliability Coordinator (RC), interconnecting utilities and telecommunication service providers
- Assists in maintenance and fault finding/repair at the converter stations and of the high voltage cables
